2019 FOUR CORNERS BAR ASSOCIATION SCHOLARSHIP

This Scholarship is awarded by the Four Corners Bar Association, which is the chapter of the Colorado Bar Association for attorneys and judges in the 22nd Judicial District (Montezuma and Dolores Counties).

Graduating seniors who will be attending an accredited College or University are eligible. There are no requirements that any specific major course of study be pursued. All graduating seniors attending Montezuma Cortez High School, Dolores High School, Dolores County High School, Mancos High School, and Southwest Open High School are eligible to apply for the Scholarship. Direct family members of members of the Four Corners Bar Association are ineligible.

The 2019 Scholarship award is for \$500.00, which may be renewed for three additional years at \$500.00 per year (for a total Scholarship award of \$2,000.00). To receive a renewal scholarship, the Recipient must provide satisfactory evidence that he or she is enrolled for the upcoming school year as a full time student at an accredited College or University, and that the Recipient maintained at least a 2.0 GPA for the preceding school year while also enrolled as a full time student.

Scholarship applications must be postmarked by <u>April 19, 2019</u> for consideration. Instructions are set forth on the Application. Selection of the Recipient will be made by the Scholarship Committee of Bar Association members.

Finalists may be selected for an interview; however, the Committee may also award the Scholarship based solely upon the information contained in the application.

The Scholarship is not need-based; however, financial need may be considered by the committee.
