- L. CALL TO ORDER The Dolores School Board special meeting was called to order at 7:35 a.m. on July 11th, 2018.
- II. ROLL CALL Members present were: Casey McClellan, Vangi McCoy (telephonically), Kay Phelps, Dee Prock and Deanna Truelsen. Phil Kasper, Interim Superintendent and Doreen Jones, Finance Manager were also in attendance.
- III. APPROVAL OF AGENDA

Approval Of:

Athletic Director: Rick Edwards

A motion was made by Deanna Truelsen and seconded by Casey McClellan to approve the hiring of Rick Edwards as the Athletic Director.

Discussion: Mr. Kasper reported that this candidate was instrumental in starting the athletic program at Bayfield schools. Mr. Edwards also was instrumental in Shiprock sports. Mr. Kasper supervised Mr. Edwards for about four years while working as assistant principal and principal at Shiprock HS. This last year he was principal of the Shiprock MS; so he's had an administrative role more recently. He is currently retired, living in Cortez. Mr. Edwards was the unanimous selection by the interview committee.

Approval Of:

Middle School English Teacher: Sarah Carr

A motion was made by Deanna Truelsen and seconded by Casey McClellan to approve the hiring of Sarah Carr as the Middle School English Teacher.

Discussion: Mr. Kasper reported receiving a very limited number of applicants for this position. Ms. Carr is from the Boettcher program. Mr. Kasper's knowledge of this candidate is limited; Ms. Hufman handled these interviews. Not sure if there were certified applicants that applied. Mr. McClellan asked how many interview committee folks and if there were parents? Mr. Kasper reported yes, there were; Ms. Hufman followed the wishes of the board in the interview process. Mr. Kasper has not spoken with Ms. Hufman directly regarding this candidate; she did send the paperwork to Mr. Kasper. Mr. McClellan would like to know her experience; Mr. Kasper believes this is her first year teaching. Ms. Phelps is interested in what her Boettcher experience entailed. Mr. Kasper is hesitant to proceed if the board has unanswered questions; the board can make this decision during the August meeting or even during the retreat; giving Mr. Kasper the opportunity to answer questions. Ms. Prock feels approval needs to take place before school starts. Mr. Kasper suggested starting with the candidate pending board approval. Ms. Jones reported in the past, the superintendent gave them the preliminary okay, the applicant was paid at their contract rate, but working as a substitute until final board approval. Mr. McClellan doesn't want to hire unqualified folks just because there weren't enough candidates. Ms. Phelps has reservations about the Boettcher program in general, because the residents have very limited experience, compared to a traditional four-year program. If Ms. Carr's experience is with English/Language Arts, she would be more comfortable with the candidate. However, Boettcher is very limited in training their program participants. Ms. Prock is comfortable moving forward with final approval being done at the August 1 retreat. Mr. Kasper reported it's not unheard of starting the year with a substitute; although, that's not best for kids. Ms. Prock would like more information by August 1 to make the decision. All agree.
