RE-OPENING PLANS FOR SCHOOL 2020



Highlights:

School will resume a week-long quarantine period. All activities prior to that date. Please check the website calendar.

- Teachers will report on August 12, other school classified staff will report on August 19.
- All schools will open with full in-person learning.
- Remote learning **will continue to be an option** for families.

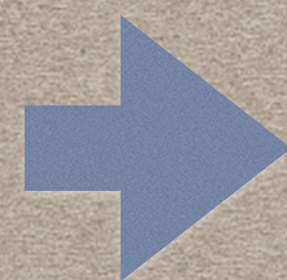

DISTRICT NEEDS TO KNOW BY AUGUST 3

(TO THE BEST OF YOUR ABILITY)

- In person instruction...or
- Fully online through the district
- Livestreaming daily class instruction



We will provide a fillable form on the website in order to choose your option.

This will enable us to make decisions based on the number of students in each category.

THE BASICS

- **In-Person Learning:** 100% in-person learning, grades PreK - 12.
- **Remote Learning:** Families have the option of remote learning, grades PreK - 12.
- **Cohorts:** Students will be grouped in cohorts during in-person learning.
- **Food & Nutrition:** Meal service program available with a combination of in-school serving and a "grab & go" program. Students will eat in their classrooms or other designated areas to support social distancing.
- **Transportation:** Bus transportation will be available for eligible students with new protocols for sanitizing and distancing.

BASICS CONTINUED...

- **Visitors:** Volunteers, visitors, or non-employees will not be allowed to enter the building during the school day.
- **Specials and Electives:** Guidelines to promote safe participation within all specials and elective programs including Visual Arts, Music, Choir, Band, PE, and Theatre will be communicated before the start of school.
- **School Schedules:** Schools will be developing their building schedules and logistical plans for pick up/drop off, symptom screening, building entry, transitions throughout the school day, lunch/recess schedules, etc. and will communicate these details to families before students arrive in August.
- **Code of Conduct:** Students enrolling for in-person learning are expected to adhere to all public health guidelines, protocols, and procedures; attendance at school will serve as agreement to these terms.

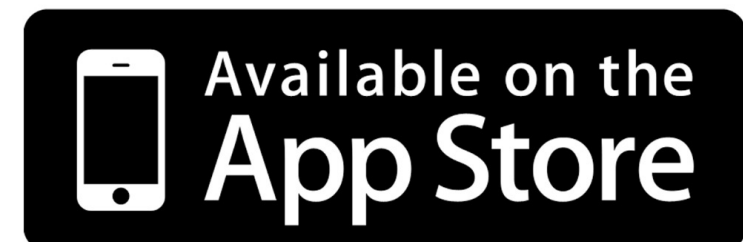

- Consider ways to accommodate needs of children and families at high risk

- Prepare
- Teach and reinforce healthy hygiene
- Develop information sharing system
- Intensify cleaning and disinfection
- Monitor for absenteeism
- Assess group gatherings and events
 - consider postponing non-critical gatherings and events
- Require sick students and staff to stay home
- Establish procedures for someone becoming sick at school



School Bus Passengers Expectations:



- * Parents will be expected to take their child's temperature before leaving the house and to withhold an ill student from riding the bus.
- * Students must sit one per seat on the school bus starting from the second row of the school bus.
- * If students live in the same residence, those students will be required to sit together in the same seat to increase rider capacity.
- * When students enter the school bus, they will load the bus from the rear to the front of the bus and unload the school bus from the front of the bus to the back (similar to some airlines).
- * Students must stay in their seats and not change seats
- * Students will be required to wear face coverings on the bus.
