In the news...

Hello parents,

I hope this year has been wonderful for you all. I know we are settling in with our new routine. I would like to address some safety concerns I am seeing during pick up.

I have noticed several vehicles parking in the red zones as well as having your children cross Central Avenue, in between cars by themselves. This is not safe for any parent or student.

If you have a student that exits the Elementary School by the clinic and you go to pick them up, please use the crosswalks, both going and coming back. DO NOT have your child walk in between the parked vehicles and then cross Central Avenue to meet you. Traveling vehicles cannot see them, and I have seen several kids just dart out in front of moving vehicles, and run across the street. So if you could please have them use the crosswalk at the corner of 12th Street that would be greatly appreciated.

I have the red zones blocked off because there are fire hydrants there and it is illegal to block a hydrant. This is not a drop off or pick up area. The red zone by the corner of 12th Street is blocked off because it helps drivers see kids in the crosswalk. So please do not park or block this area.

The designated drop off and pick up area is In front of the Elementary School along 12th Street. If your child enters through the double doors by the clinic then they can be dropped off on 12th street before the staff parking area.

Also please remember the school zone on Railroad Avenue (14th Street to the Post Office) is in effect from 7:30-8:15 and from 3:20-4:00, and the speed limit is 25 miles an hour. Any violation doubles in a school zone.

<u>Counselor's Corner</u>

Hello Little Bear Families!

A couple of weeks ago we explained the whole school Positive Behavior Supports we are starting to implement. The students will be able to turn the bear paw tickets they earn in for tangible rewards as well as fun privileges through the virtual Little Bear Trading Post! Mrs. McCormick even offered some Pokemon Go time as a privilege they can save for, but they can also purchase other items like fishing poles, pencils, Build a Bear costumes and other donated items. Teachers will catch them keeping the rules and being resilient when difficult situations arise. Many of Mrs. Christensen's students have used their bear paw tickets to purchase Moochie Squishies!

We also explained that when the students are not showing positive behavior the focus will be on having them reflect on their negative behavior and come up with a plan to avoid it in the future by replacing it with a positive alternative. If the plan they make with the teacher in their room does not change the behavior, they will be sent to a "buddy room" to try to come up with another plan. Parents will be receiving a call from the teacher at this point and the reflection sheet will come home for your signature. If that plan does not work ... and frequent minor misbehaviors continue they will receive an office referral. At this point parents will receive a call from the principal and yet another plan will be implemented with Principal, parent, teacher and student input. Keep in mind that the "Plans" include consequences. Negative reinforcement combined with positive reinforcement is often what is needed at that point. Serious negative behaviors will go directly to an office referral. Please let me know if you have any questions or concerns.
