ACTIVITIES:

Operation Graduation:

Christina E. reported on Operation Graduation. Donations are coming in as of their last meeting they had received \$1,320 and more donations are coming in and that number is now closer to \$4,000. The officers have organized and cataloged all the materials and supplies, instructions, etc. that can be passed on to next year's officers. Melissa will send OG's minutes to the Booster Club to be kept.

Student Council: Nothing to report at this time.

Old Business:

- Memory Tree for Rob Mellott- tabled until next month since Rene was not able to attend.
- Parent Teacher Conferences – March 2-5th –
Talked about supporting local businesses and doing Taco Bar on Tuesday and Sandwiches and Salad on Wednesday. Katie and Susan will set up the food. Pam made a motion that we purchase sandwiches/wraps and salad from 3 Chicks Bakery on Wednesday and Taco's from Montezuma Restaurant for Tuesday's PT conf teacher dinner. Shelly seconded motion. Shelly said she will contact Montezuma and Kim will contact 3 Chicks. Brenda will get the drinks and paper-goods for the meals and bring them to the school.
- Senior Banners – Shelly reported that the district will be doing senior banners again this year. Discussion was held about Booster Club proving some financial support and how much that should be. A suggestion of a minimum dollar amount be set that we would contribute this year and possibly in future years. This amount could be increased on a year to year basis based on Booster Club's budget each year. Brenda made a motion "that for 20-21 school year we give the

district \$500 dollars to help with the purchase of senior banners”. Melissa seconded the motion. No dissention was heard and motion passed.

New Business:

- Request for funds from Track – A request was received from Brook Elder to purchase 30 bucket hats at \$21 a piece for a total \$664.78 that track participants will keep. Discussion was held and a motion was made by Melissa “that we purchase the bucket hats for the track team at a cost of \$664.78 for this year and that if they are needed again next year the athletes will use them again”. Shelly seconded the motion. Motion passed.
- Operation Graduation Donation – Christina shared the need for funds for OG. Shelly made a motion “that we donate \$500 to Operation Graduation as we have in the past”. Motion was seconded by Brenda. Motion passed.
- Baseball Team – Sweatshirt need
Melissa shared that the baseball team needs to replace 2 sweatshirts for this year. Following discussion, Shelly made a motion “that we replace the 2 sweatshirts for the Baseball team for this year.” Motion was seconded by Brenda and motion passed. Cost will be around \$80 for both.
- Cheer Competition meal money (10 girls?) Brook Steiglemeyer and Shauna Wark presented a request for provide funds to help the cheer squad to attend a cheer competition. The request is for a meal for the team while they are attending the cheer competition in Colo Springs. After discussion, Melissa made a motion “that we give the cheer squad \$200 (\$15 per person for 12 people plus tip) to use this year.” Brenda seconded the motion. Motion passed.
