The meeting was called to order at 5:02 pm.

Secretary Minutes: Minutes from the March 7th meeting were shared by Pam. Shelly made a motion to approve the minutes. The motion was seconded by Pam. The minutes were approved.

Treasurer's Report: Kim shared the treasurer's report for March. The beginning balance was \$3,760.40. Total deposits were \$361.84 and total expenses were \$931.48. The ending balance was \$3,190.76. Kim also shared projections for final expenditures as the end of the year wraps up. Shelly made a motion to approve the treasurer's report and Rene seconded the motion. The treasurer's report was approved.

Concessions Report:

Concessions are done for the year. Rene shared that there are still some perishable items left as well as chips and lots of pop. Anything that's not perishable such as Pop and chips will be donated to Operation Graduation. Rene shared that Elizabeth Edwards has indicated that she would be willing to head up concessions next year but we still need another person to work with her.

Operation Graduation Report:

Shelly suggested that the Boosters recognize her accomplishment by giving her some monetary support. After discussion, Kim made a motion that we give Shiloh \$200 to help with expenses to accept her award. Pam seconded the motion. Motion passed.
- Senior Banners – Susan is checking on who is ordering the banners for the seniors. Last year we helped with the cost of these and can help again this year for an amount not of \$500. Pam made a motion that we contribute up to \$500 toward the cost of the banners. Motion was seconded by Kim. Motion passed.
- Election of New Officers – These are the open Booster Club positions: President Elect, Vice President, Secretary, Concessions Coordinator and Co-Coordinator. Positions NOT open are President and Treasurer. The following people were nominated:
