



Dolores Bears Booster Club Meeting Minutes

- They have the rec center reserved, they now need insurance

- They spoke at the board meeting and they were given \$1,500.00
- Crumble Cookies for PTC raised \$607.66 sold out the first night.
- They have committed to concessions for baseball. 4/9/24 4/18/24 4/23/24. There is a concession sign up sheet in the band app. They are doing walking tacos and hot dogs
- Student survey with 9 responses with their desires.
- They are meeting again tonight.
- Shelly spoke to Kristina at Montezuma Mexican Restaurant for the Senior Lunch and Scholarships. She agreed and it will be May 22, 2024 at noon with a taco bar (this worked well last year). Shelly and Rylee will be there to represent the Booster Club and hand out the checks (\$250.00 for 5 students) for scholarships. An announcement will need to be made to let the seniors know the check will need to be cashed within 6 months of receiving the check. The seniors last day of school is May 16th. They have awards night May 21st. Wednesday, May 22nd will be the booster senior lunch and scholarships, then the seniors will need to be back to do the rehearsal and the senior walk of fame at 2:45 PM and senior graduation parade will be that night at 6:00 PM.
