Secretary Minutes: Motion was made by Rylee to approve of the minutes from the August 13 Booster Club Meeting. The motion was seconded by Staci and the motion passed.

Treasurer's Report: Staci presented the Treasurer's report. She shared the balance from 3/31/25 of \$4,929.88. The current amount in the account is \$4,692.58, and with a few pending transactions will be \$3,187.69.  - Motion was made by Megan to purchase iPad for \$200 instead of Square device, seconded by Staci and the motion passed

NEW BUSINESS:

 World's Finest Chocolates - Melanie Barger from World's Finest Chocolates shared information about potentially selling chocolate bars at concessions. Recommended selling \$2 bars; they are phasing out \$1 bars. Minimum case order is 8. We pay \$36/case for 30 bars, thus making \$24 profit per case. Shipping is \$120 no matter how many cases we purchase, but if we purchase 50 boxes, she will throw in a few more for free to help offset the shipping cost. Discussion about possibility - like the idea, but don't currently have enough funds to justify purchasing a large number of cases. We will revisit after Homecoming
