The meeting was called to order at 5:40 PM by Rylee.

Secretary Minutes: Motion made by Staci to approve of the minutes from the February Booster Club Meeting. The motion was seconded by Nina and the motion passed.

Treasurer's Report: Staci shared the treasurer's report for March. The beginning balance from 03/04/26 was \$8,080.38. The ending balance as of 03/26/26 was \$6,170.56. Staci also shared some expected end of year expenses, including: Senior lunch \$500, Bear Backer mailing supplies \$50, money saved for next year's starting expenses \$1,000, and Just Because scholarships \$1,250. Gabi made a motion to approve the treasurer's report. Rylee seconded and the motion passed.

Concessions Report: There will be one HS baseball concession.

Operation Graduation (OG): OG currently has \$15,000. They are expecting another \$1,500 from the school board, \$500 from Kiwanis, and \$1,000 from 12 Hours of Mesa Verde. They are also planning to do concessions at the play.
